Older Youth: Successful Transitions Program

Organization Statement:

Since 1885, The Children's Home of Easton has provided a caring, nurturing environment for children in need as well as assistance for their families. Our goals are to guide, support, and encourage children to believe in their own self-worth and reach their full potential.

The Home offers a continuum of care for children dealing with abuse, neglect, and other traumatic experiences. Our services include emergency housing, campus group homes, community group homes, specialized foster care, foster care, independent living, day school, therapeutic services, family-based programs, and much more.

Program Overview:

The overall goal of the Older Youth: Successful Transitions Program is to empower, educate, and provide a smoother transition for youth in our care into adulthood. The program provides endless opportunities for growth and development, and the need for this program is very prevalent for the population we serve. In 2019, we continue to see positive outcomes from the Older Youth: Successful Transitions Program, and as always- we continue to address improvements that can be made in order for the program to reach its full potential and guide our youth to independence.

Through schooling and employment, along with other responsibilities and requirements through the program, the older youth are provided with many opportunities for advancement and future success.

One of the problems we have addressed this past year is the quick turnover of kids in our care. Due to legislation and government funding, we are seeing more kids, for shorter periods of time. Because of this, we continue to offer a program called "Zigmund Reality," a condensed version of the Older Youth program. Zigmund Reality is a two-week program that touches on many of the same important life lessons and living skills. With this taste of what is ahead of them many choose to pursue the Older Youth Program.

Thanks to the generosity and past support of organizations like Easton Rotary, The Children's Home can provide our youth with great programs that aim to develop them into well-rounded, successful adults.

Proposal Summary:

If you choose to provide funding to the Older Youth: Successful Transitions Program, it would be allocated to cover the costs of caring for the individuals enrolled in the program. These costs include food, housing, transportation, and education.

In order to begin this program, the older youth must interview with the Director of Older Youth Services and the Executive Director of the Children's Home of Easton and be accepted into the program. The purpose of the interview is to ensure the applicant is committed and serious about growing and transitioning into a successful, contributing member of society.

Each participant is required to meet a minimum of one (or more) of these criteria: pursuance of postsecondary or vocational education; participation in a program actively designed to promote or remove barriers to employment; or full-time employment. The youth are responsible for reporting to the Director of Older Youth and other staff members to ensure they are meeting requirements and more importantly- understanding the important life lessons this program teaches.

Project Description:

The Older Youth program continues to consist of a full range of services to evaluate and improve the skills necessary to plan for each youth's advancement to independence. It is very competitive to be selected as a participant of the program, as the older youth are held to a high standard and must follow the expectations outlined by the Home.

Through the Older Youth: Successful Transitions Program, the youth are provided housing that is set up much like a college efficiency, with a staff member (Resident Advisor) who provides guidance to the older youth and is available 24/7 within the same building. The overall goal of this program is to help the older youth achieve independence and prepare them for their future once their time at the Home is over. This program also allows staff to ensure the older youth are mentally and physically healthy, and not falling into bad habits. The program offers guidelines in many different aspects, and provides for an easier transition for the youth in care into adulthood. Youth are encouraged to also participate in our daily Health & Wellness activities offered here on campus.

Our main objective for this year is to continue to improve the program based on the evidence we have gathered internally and to combine our data with those from other institutions to have the most effective collective impact on participants. We feel this approach continues to meet the needs of both the youth and the community alike by producing young adults with the abilities and positive self-esteem necessary to improve society as a whole.

Problem to be Addressed and Project Purpose:

With aging youth having the ability to sign out of care at 18, they would, but didn't have the necessary living skills or resources to be successful, therefore becoming dependent upon the system itself. In addition, the aging youth generally do not have a support system to go home to, which is extremely problematic. Each year, 26,000 kids age out of care and struggle or are unable to meet their needs for health care, housing and emotional support, among other basic necessities. This program is vital in the youth's advancement to independence, as it provides opportunities for education, employment, living skills, and so much more.

Population Served:

The Older Youth: Successful Transitions Program was designed for individuals between the ages of 18-25 who wish to acquire further education, employment opportunities, independent living skills, etc. to become productive, successful citizens. Currently, there are 13 older youth in the Older Youth Program, and we hope to see that number expand within the next year.

Goals and Measurable Outcomes:

The overall goal of the program is to prepare, guide, and assist the youth in our care into adulthood. The success of the program can be measured by identifying the following:

- Number/Percentage of children with independent living skills and healthy life styles
- Number/Percentage of youth maintaining employment
- Number/Percentage of children graduating from high school
- Number/Percentage of children enrolling in postsecondary education
- Number/Percentage of children graduating from post-secondary education

Work Plan:

The Older Youth: Successful Transitions Program is an ongoing program that is updated as needed in order to meet the needs of the older youth within the program. One common trend that The Children's Home of Easton is seeing is the quick turnover of the children in our care. This

has impacted our programs slightly, in the sense that the programs must cover the important lessons and content in a shorter length of time. These factors, however, do not change what the program has to offer, and the opportunities provided for the older youth. With that said, our numbers are slightly down, but they are more consistent. This year already, there have been 21 youth enrolled in the Older Youth: Successful Transitions Program. The quick turnover is due to legislation that was passed and the government funding of children services.

As these changes are taken into consideration while developing each older youth's personal transition plan, the outside factors do not take away from the need for this program. We have increased our marketing efforts for the program, which has shown a positive response. We plan to continue our outreach strategies, and will continue to make the necessary changes to the program to fully benefit our older youth.

Future Funding/Sustainability:

The Children's Home of Easton relies on the generosity of the community through foundation grants, leadership gifts, individual gifts, corporation donations, and fundraisers to provide funding for the programs we offer. Along with fundraising efforts, we have also increased our reach to new funding sources; and are always dedicated to building and maintaining relationships graciously with the past, present, and future donors of The Children's Home of Easton.

Based on information supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.
