# Miracle League of Northampton County Easton Rotary Field December 22, 2017

#### **Brief Description of the Organization**

The mission of the Miracle League of Northampton County (MLNC) is: "To create positive experiences for those with intellectual and physical disabilities and their families through baseball."

Can you picture a moment when a child in a wheelchair raises up at home plate, grabs a bat, hits a ball and with assistance walks to first base playing baseball for his/her very first time? This vision is the heart for the Miracle League of Northampton County. Inspiration, courage and just having fun are the hallmarks of what occurs at every game in the Spring and Fall seasons for the athletes that play baseball on the **Easton Rotary Miracle League field**.

Our league focuses on the athletes ABILITIES, not their disABILITIES and our mission is to create positive life experiences for those with disabilities and their families through baseball. We celebrate their growth and accomplishments every single game. When we began playing baseball at this venue in the Fall of 2012 we had 85 players. In 2017, we have 314 players which shows the need for a facility like this in Northampton County.

We continually hear comments from parents on how important playing baseball is to their children. This is the only facility in Northampton County where they have this opportunity to get both physical and intellectual exercise because this facility is built just for them.

Another benefit of our program is the interaction of the volunteer with the players. Each year we have between 1,000 and 1,500 volunteers who come to the field to be a buddy to a player. Most of the buddies are youth and this opportunity gives them a chance to work with children who have intellectual and physical disabilities and to understand their needs and also to understand that they are kids just like them. A lot of relationships have blossomed out these interactions.

Out motto is "Every Child Deserves a Chance to Play Baseball."

The Miracle League of Northampton County is a 501(c)(3) non-profit organization which was formed in August 2010.

#### **Summary of Proposal**

This grant application is to fund the purchase of two ADA Accessible Picnic Tables. As part of the MLNC facility there is a large section where there are picnic tables along with a pavilion with tables within it. For the past five years we have had a number of picnic tables but no ADA tables. Because we have a number of our players in wheel chairs and as our number of players continues to grow we feel that we need to provide the ADA tables so those in wheel chairs can comfortably fit at the table.

### **Project Description**

- Statement of need Since we have many players with wheel chairs and that number continues to grow that we need to have ADA accessible picnic tables.
- How the proposal addresses the need It will give those in wheel chairs the ability to comfortably fit at the table.
- Population to be served In 2017 we had 314 players with many of them in wheel chairs. Having said that we don't have an exact number in chairs.
- Goals and measureable outcomes Our goal is to make those that come to our facility to play baseball as comfortable as possible. The measureable is seeing that players in wheelchairs are comfortable when eating at a table.
- Other funding sources We have a grant request into Crayola for two tables.
